

**CITY OF LA HABRA
NOTICE OF PUBLIC HEARING AND REVIEW
DRAFT ACTION PLAN SUBSTANTIAL AMENDMENT**

Notice is hereby given that the City of La Habra has prepared a Draft Substantial Amendment to the 2019 Community Development Block Grant COVID-19 (CDBG-CV) Action Plan to include new projects and modify existing projects. This amendment is conducted in accordance with guidance provided by the U.S. Department of Housing and Urban Development and the City of La Habra's Citizen Participation Plan. The City of La Habra will utilize the CDBG-CV allocation to fund housing and community development programs to mitigate the impact of the COVID-19 pandemic on low- and moderate-income residents through a new strategic goal titled "COVID-19 Response."

Changes to the CDBG-CV Substantial Amendment are as follows:

- Create new project titled "Socially Distanced Parklet Installation" to develop up to two parklets along La Habra Boulevard (Budget: \$105,000)
- Reduce Rental and Mortgage Assistance project budget to \$200,188 and revise project name to Rental Assistance
- Reduce Small Business Support and Technical Assistance project budget to \$55,000

In accordance with waiver authorization provided by the U.S. Department of Housing and Urban Development, the City will provide the amendments for review and comment for a 5-day comment period on the City's website prior to the public hearing.
