#### **CONSIDERATION ITEMS:**

##### 1. CONSIDER THE FISCAL YEAR 2021-2022 PROPOSED BUDGET PRESENTATION

Director of Finance Shannon presented the staff report and a PowerPoint presentation, assisted by Department Directors and Department representatives. He spoke regarding financial budget impacts due to the COVID-19 pandemic, staff's conservative approach to the Fiscal Year 2020-2021 budget, vaccine availability, and California Governor Newsom's announced intention to fully open California's economy and its positive effect on the City's core services, community activities, events and programs. He stated that the Fiscal Year 2021-2022 proposed overall Municipal Budget totaled \$136.4 million and of that amount was the General Fund budget of \$50.3 million. He noted a \$5.7 million projected increase in General Fund revenues compared to the Fiscal Year 2020-2021 Municipal Budget, a \$2.8 million increase from the March 2021 estimate, and a \$4.7 million increase in General Fund expenditures. He reviewed the new and restored and the various proposed General Fund budget balancing measures.

City Manager Sadro stated that the Transaction Tax in the General Fund budget referred to Measure T, a half-cent local sales tax that currently generates \$5.9 million in revenues, was scheduled to sunset in the year 2028. He pointed out a notable property tax revenue rate increase and a sales tax increase on the 10-year General Fund History chart.

Councilmember Gomez left the dais at 7:04 a.m. He returned at 7:06 p.m.

The following Department Directors and/or staff representative spoke regarding their department budgets, including major accomplishments and goals, and stated department highlights as follows:

Councilmember Gomez left the dais at 8:26 p.m. He returned to the dais at 8:28 p.m.

Mayor Pro Tem Medrano left the dais at 8:29 p.m. He returned at 8:31 p.m.

Director of Finance Shannon provided an overview of the budget summary by fund, and stated that the total General Fund Municipal Budget was \$136,440,988 million. He indicated that the budget was balanced by budget cuts and spending controls, phased hiring, and proposed freezes of certain vacant position.

Finance Manager Ponvanit provided a brief overview of Pension Cost History and Forecast.

City Manager Sadro provided further clarification on the CalPERS Safety Contribution Rates as a Percentage of Payroll, and stated significant financial and payroll impacts to the City of La Habra were anticipated within the next 10 years. He spoke regarding Full-Time Equivalent Employees (FTEs) 19 Fiscal Year Comparison, and how City service levels are negatively affected by decreased staff levels.

Director of Finance Shannon reviewed the future budget challenges and the Implemented and Potential Pension Strategies.

City Manager Sadro stated that an additional item to the pension strategies included City Council approval for staff to research a Pension Obligation Bond (POB) as a resource.

City Council discussion included: use of funds from former Gary Center for the Employment & Training program; confirmation that the Tamale Festival would be a one-day event; continued security at the Skate Park; suggested increase of \$1,500 to fund a Mariachi band during the Concerts in the Park Series; shortfall in number of Police Officers; potential state assistance with pension liabilities; strategies to fund unfunded liabilities; clarification that the 12.6 percent revenue increase excludes COVID-19 relief funding; confirmation that an additional 20 spaces of parking would be installed at the south side entrance of Oeste Park; confirmation of Pavement Condition Index (PCI) scores of 81.9 for residential, 83.3 for arterial, and 69.5 for alleyways; verification that the La Quinta project is taking longer because the developer was moving slowly through the process; confirmation that after the five officers coming onboard had begun working for the City the La Habra Police Department would be down three officers; strategy development to fund the PERS unfunded liability debt; confirmation that the State of California monies to be received by the city from the federal government would not fund the PERS unfunded liability debt and was not included in the 12.6 percent increase in revenue; verification of the recent receipt of the first portion of the COVID-19 relief funds and that the second half of the funds would be received in a



year's time; confirmation that the guidelines for the COVID-19 relief funds had not yet been received by the City; and review of national debt numbers, the expectation of inflation affecting the nation soon, and the potential for the City to receive state funding.

Mayor Espinoza invited the public to testify at 8:55 p.m. There was no public testimony.

Public Works Director Saykali presented the staff report and gave a brief PowerPoint presentation. He verified that there was a good chance to receive Proposition 68 grant funding for this project.

City Attorney Jones left the dais at 9:04 p.m. He returned to the dais at 9:10 p.m.

City Council discussion included: confirmation that Vista Grande Park Development project input was received from both La Habra High School and Sonora High School students; verification that the amphitheater would be built in a location minimally intrusive to surrounding residential complexes; and appreciation to St. Jude Hospital and the grant funding they have provided to the City for this project and for former exercise equipment, and encouraging the community to move more and eat healthy.

Mayor Espinoza invited the public to testify at 9:16 p.m. There was no public testimony.

City Manager Sadro clarified that upcoming community events and activities included Splash Pads at Brio and Oeste Park; Movies in the Park; and Concerts in the Park Series were free of charge.

**COMMENTS FROM COUNCILMEMBERS:**

Mayor Pro Tem Medrano requested the meeting be adjourned in memory of Los Angeles County Fire Department Firefighter Tory Carlon who was killed on June 1, 2021, in the Station 81 shooting located in the Agua Dulce area. He stated that the California Highway Patrol made an arrest in the 55 Freeway shooting death of six-year-old Aiden Leos and extended a thank you to the California Highway Patrol and the Orange County District Attorney for their investigation. He stated that he attended the La Habra High School and Sonora High School graduation ceremonies. He congratulated Mayor Espinoza on her upcoming Cal State University, Fullerton (CSUF) graduation and presented her with CSUF items on behalf of Councilmember Gomez and himself.
