## APPLICATION FOR 2022 OVERNIGHT PARKING PERMIT

**Restrictions:** Parking permits are not issued to motor-homes, boats, trailers, trucks with campers larger than a shell, or commercial vehicles used for business (over 6,000 pounds). No vehicle, including those with parking permits, will be allowed to remain standing (parked) on any street for more than 72 consecutive hours (22651(k) CVC). Permits shall be considered on a basis of need and not issued solely for convenience. Vehicle must be registered at same address as applicant, driver must have a valid driver's license with the same address.

**Fee Schedule:** Full calendar year- \$37.00. If more than one permit is issued, the charge for each additional vehicle is \$19.00. Replacement fee of a lost or stolen permit is \$7.30
