

## LEGAL NOTICE

NOTICE IS HEREBY GIVEN THAT on Monday, February 9, 2026 at 6:30 p.m., or as soon thereafter as the matter may be heard, the City of La Habra Planning Commission will hold a public hearing on the following item:

ZONE CHANGE 26-0001 TO AMEND CHAPTER 18.72 (“ENFORCEMENT”) AND REPEAL CHAPTER 18.74 (“NEIGHBORHOOD PRESERVATION, CODE ENFORCEMENT AND ABATEMENT”) OF TITLE 18 (“ZONING”), ADD CHAPTER 8.16 (“PUBLIC NUISANCES”) TO TITLE 8 (“HEALTH AND SAFETY”), AMEND SECTION 13.20.030 (“DESIGN”) OF CHAPTER 13.20 (“TEMPORARY SANITARY FACILITIES”) OF TITLE 13 (“PUBLIC SERVICES”), AND REPEAL CHAPTER 10.36 (“ABANDONED, WRECKED, DISMANTLED OR INOPERATIVE VEHICLES”) OF TITLE 10 (“VEHICLES AND TRAFFIC”) OF THE LA HABRA MUNICIPAL CODE

The Zone Change was reviewed pursuant to the guidelines of the California Environmental Quality Act (CEQA) and determined to be exempt pursuant to Sections 15378(b)(5) and 15061(b)(3) of the CEQA Guidelines. The Zone Change is not a project pursuant to Section 15378(b)(5) of the CEQA Guidelines because it is an administrative activity of the City that will not result in direct or indirect physical changes in the environment. Even if the Zone Change were considered a project under CEQA, it would be exempt pursuant to Section 15061(b)(3) (Common Sense Exemption) of the CEQA Guidelines because the proposed amendments to the La Habra Municipal Code have no possibility of having a significant effect on the environment.

The public hearing will be held in the City Council Chamber located at 100 East La Habra Boulevard, La Habra, California 90631.
